# 173rd Annual Convention Minutes

# of the Episcopal Diocese of Milwaukee October 3, 2020 Virtual

# Saturday, October 3rd

### **Business Session**

The Rt. Rev'd Steven A. Miller, President of the Convention and Presiding Officer, convened the 173rd Annual Convention of the Episcopal Diocese of Milwaukee at 10:14 a.m. on Saturday, October 3, 2020.

Bishop Miller opened the session with collects for a Church Convention, for the Nation and for Unity within the Church and the Lord's Prayer.

Bishop Miller called the meeting to order.

### Roll Call & Determination of a Quorum

Bishop Miller inquired of the Mr. John Washbush, Parliamentarian, regarding the presence of a quorum and the certification of members. Mr. John Washbush, on behalf of the Executive Secretary, reported that there were 221 deputies in attendance: 68 clergy and 153 lay; that a quorum was present, and that the lay deputies for all the parishes and all clerical members had been certified.

Mr. John Washbush then explained the special rules of order that govern today's meeting, several needing the support of the convention:

- --virtual rules of order supersede regular rules of order
- --votes will be conducted through a voting app.; there will be no voice votes
- --any technological failing on the part of a participant will not cause the Convention to be invalid

Mr. John Washbush called for a poll vote to support, not to support or to abstain from the adoption of the Special Rules of Order.

The Special Rules of Order were adopted.

Bishop Miller asked if there was any objection to waiving the reading of the minutes. Hearing none, he asked if there were any corrections or additions to the minutes of the 172nd Convention of the Episcopal Diocese of Milwaukee. Hearing nothing further, Bishop Miller announced that the minutes were approved as presented.

Bishop Miller announced that all nominations were closed.

Bishop Miller recognized Mr. John Washbush, the Parliamentarian, for an explanation of balloting procedures. **The Conduct of the First Ballot began.** 

Bishop Miller announced that the balloting would continue while other matters of business would be addressed.

### **Consideration of Resolutions**

Bishop Miller stated that four resolutions before the convention would be considered in the order appointed.

#### **Resolution I**

Amendment to Canon 6 - Of Elections

Whereas: Changes of communication technology have decreased the time required to disseminate

information to the deputations of the convention; and,

**Whereas:** The Rules of Order for the Convention of the Diocese of Milwaukee already reflect this

communication efficiency by having changed the deadline for submission of nominations

and business to be brought before the convention; therefore, be it

Resolved: That section 1 of Canon 6 - Of Elections be amended to reduce the deadline for submission

of nominations for elections from 60 days prior to the convening of Convention to 45 days,

as indicated below:

CANON 6 - Of Elections.

SECTION 1. Nominations for the elective offices hereafter set forth shall be made not less than 45 days prior to the convening of Convention by any adult communicant of the Diocese in good standing, such nominations to be made in writing addressed to the Secretary of the Diocese. Such elective offices are the following: (section continues without further changes)

Bishop Miller stated that Resolution I – Amendment to Canon 6 - Of Elections had been placed before the convention and that because a Committee had brought the Resolution, it is considered moved and seconded. Bishop Miller asked if there was any discussion on the resolution. Hearing nothing, Bishop Miller called for a vote on the resolution. The resolution passed as presented.

#### **Resolution II**

Amendment to Canon 4 - Of The Meeting of the Convention

Whereas: The Special Convention of July 16, 2020 adopted canonical changes that make it possible for the

Diocese of Milwaukee to meet in convention virtually for the fall of 2020; and,

Whereas: Those canonical changes authorize the format of meeting at a distance electronically

only for this convention; and,

Whereas: There will remain in our future the possible need to meet as a convention in a format other

than face-to-face in a single location; therefore be it

Resolved: That section Canon 4 - Of The Meeting of Convention be amended to remove time

specific references to meeting virtually to read as follows:

Canon 4 - Of the Meeting of Convention

1. The Convention of the Church in the Diocese shall be held at such time and place as the Bishop, or the Ecclesiastical Authority, shall designate.

2. At the request of the Bishop or Ecclesastical Authority, and subject to the concurrence of the Executive Council, such meeting may be conducted through the use of internet meeting services designated by the Bishop, or the

Ecclesiastical Authority, that support anonymous voting and support visible displays identifying those participating, identifying those seeking recognition to speak, showing (or permitting the retrieval of) the text of pending motions, and showing the results of votes.

- a. The electronic meeting of such Convention shall be subject to all rules of order adopted by such Convention to govern them, which may include any reasonable limitations on, and requirements for Members' participation. Any such rules shall supersede any conflicting rules in the parliamentary authority, but may not otherwise conflict with or alter any provision of the Constitution or Canons of this Diocese.
- b. An anonymous vote conducted through the designated internet meeting service shall be deemed a ballot vote, fulfilling any requirement in the Canons or rules of order that a vote be conducted by ballot.

**Whereas:** The resignation of The Rt. Rev. Steven Miller as 11th Bishop of the Diocese of Milwaukee will be effective January 1, 2020; and,

**Whereas:** The Standing Committee of the Diocese of Milwaukee, in consultation with Bishop of Milwaukee and the Office of Pastoral Care of the The Episcopal Church, has discerned a need for an episcopal presence in the Diocese of Milwaukee to support the work of the church, the search for the 12th Bishop of Milwaukee, and the transition to the next bishop; therefore be it

**Resolved:** That the 173rd Convention of the Diocese of Milwaukee:

- 1) approves the creation of the position of Assisting Bishop for the Diocese of Milwaukee, effective January 1st, 2021
- authorizes the Standing Committee of the Diocese of Milwaukee to develop a Letter of Agreement including a description of the position and the qualifications of candidates for appointment
- authorizes the Standing Committee to appoint a Bishop for the position, subject to the concurrence of the Executive Council of the Diocese of Milwaukee

#### **Resolution IV**

2021 Clergy Minimum Compensation

Whereas: We are currently experiencing unprecedented circumstances in our life as a Diocese and as parishes and currently there is no method to adequately or accurately predict the financial impact on parishes during the coming year; and,

**Whereas:** In recognition of this inability to assess and predict the Diocese is proposing fiscal procedures for next year that use the present year as a working starting point;, and

**Whereas:** The adoption of a minimum compensation standard for clergy is not just a canonical requirement but also a matter of ensuring fair treatment of the clergy of the diocese; therefore be it

RESOLVED: That the clergy compensation levels for 2021 remain at the 2020 levels (see below). This action does not prohibit a parish from compensating clergy beyond the standard nor increasing clergy compensation in the coming year, in accordance with individual parish circumstances. If extenuating circumstances may prevent a congregation from meeting these minima, any proposed exceptions to this compensation standard must be approved by the Office of the Bishop / Ecclesiastical Authority.

Bishop Miller stated that Resolution IV -2021 Clergy Minimum Compensation been placed before the convention and that because a Committee had brought the Resolution, it is considered moved and seconded. Bishop Miller asked if there was any discussion on the resolution. Hearing nothing, Bishop Miller called for a vote on the resolution. The resolution passed as presented.

Bishop Miller explained that in the past, the Necrology was submitted as a list in the deputy packet or part of the Morning Prayer. He further said that, today, there will be a special presentation, prepared by Ms. Sara Bitner, of the names and faces of those died in 2020. There will be a musical accompaniment from Ms. Stephanie Seefeldt.

## 2021 Diocesan Budget – A Parliamentary Moment/Budget Proposal

Bishop Miller recognized Mr. John Washbush, Dispatch of Business, for the purpose of clarifying the conduct of business pertaining to the budget. Mr. Washbush explained the procedures for approving the budget and parish assessments.

Bishop Miller recognized the Rev. Kevin Huddleston, Canon for Finance and Administration, for the budget report.

The Rev. Kevin Huddleston expressed his gratitude to and for Mr. Clyde Bachand, previous Diocesan Treasurer, and for the Finance Committee. He explained that the 2021 Diocesan Budget was a static budget, holding the income and expenses to the current amount. He further noted that the assessments will either remain the same or be reduced depending on the method for factoring the amount. He asked that parishes consider electronically depositing checks both from the parish to the diocese and for their parishioners. He assured the Convention that there will be monthly review of the financial status of the diocese. He will also be offering educational meetings for the Wardens and Treasurers.

Bishop Miller asked if there were any questions, again noting that this was the time for questions seeking information or clarification not for debate.

The Rev. Jonathan Greiser (Grace, Madison) asked about the increase in diocesan staff expenses. Canon Huddleston noted that partly it was due to covering the salaries of St. Francis House and the Hospitality center and partly due to increasing health insurance costs.

The Rev. Seth Raymond, (St. Luke's, Racine) asked about monies to cover the cost of a Provisional Bishop. Canon Huddleston noted that a, line item, to cover the transition expenses, was approved in last year's budget.

The Rev. Miranda Hassett (St. Dunstan's, Madison) asked if a "rolling" budget allows for adjustments. Canon Huddleston stated: "Yes."

Seeing no further request for discussion, Bishop Miller opened up debate on the proposed 2021 budget. Having no request for debate, Bishop Miller called for a vote to adopt the 2021 budget by poll. 97% approved.

Bishop Miller called on the Rev. Joel Prather, Vice-President of the Executive Council. The Rev. Joel Prather announced a presentation of tributes, from staff and diocesan members. It was a virtual "gift" expressing their thanks and blessings for the life and ministry of the 11<sup>th</sup> Bishop of the Diocese of Milwaukee, the Right Reverend Steven A. Miller.

## **Report of Individual Resolutions of Privilege and Courtesy**

### The Rev. Steve Capetelli presented the following resolution:

WHEREAS the Haiti Project of the Episcopal Diocese of Milwaukee has for over thirty years formed and been in a mutually beneficial Christian relationship with the people and parish of St. Marc's in Jeannette, Haiti; and

WHEREAS during that time, St. Marc's School has provided and continues to provide excellent educational opportunities to the children of Jeanette; and

WHEREAS during that time St. Marc's Clinic has provided and continues to provide much needed health care to the people of Jeanette; and

WHEREAS Carl and Mary Alice Eschweiler were founding members of the Haiti Project of the Episcopal Diocese of Milwaukee and have devoted countless hours in fund raising, organizing and building said mutually beneficial relationship by visiting our brothers and sisters in Jeanette; therefore,

BE IT RESOLVED that this 173rd Annual Convention of the Episcopal Diocese of Milwaukee recognize and thank Carl and Mary Alice Eschweiler for their service in our name to our brothers and sisters in Christ in St. Marc's and the village of Jeanette, Haiti.

### The Rev. Scott Leannah presented a closing resolution:

BE IT RESOLVED that at this 173<sup>rd</sup> annual Convention of the Episcopal Diocese of Milwaukee, we all give grateful thanks for the ministry of our Bishop, The Rt. Reverend Steven Andrew Miller. We express our gratitude for his 17 years of episcopal ministry, for the ways his time among us was a blessing and a gift, and in recognition of the transformation, growth and development that has marked his time among us.
