The Rev. Matthew Buterbaugh (St. John's, Burlington)



Fr. Matthew Buterbaugh has been in the Diocese of Milwaukee for almost ten years. In this time, he has served in several capacities in the wider church. These have included serving as dean of the South Convocation for seven years, a number of diocesan roles, and on the Unity and Relations Committee of the Wisconsin Council of Churches. The Rev. David Simmons (St. Matthias, Waukesha)

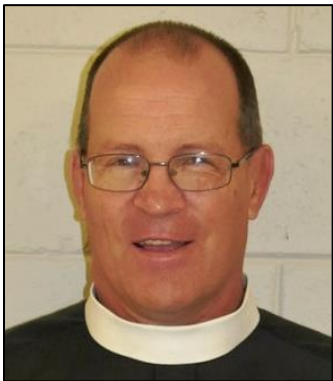

John N. Vogel (Trinity, Wauwatosa)

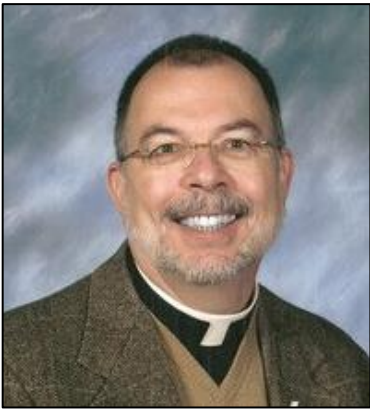

The Rev. T.J. Humphrey (St. Paul's, Beloit)

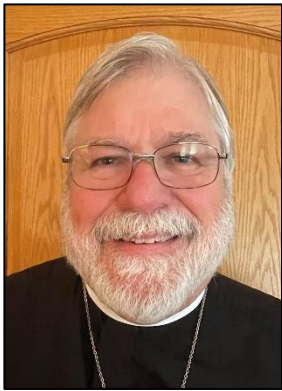

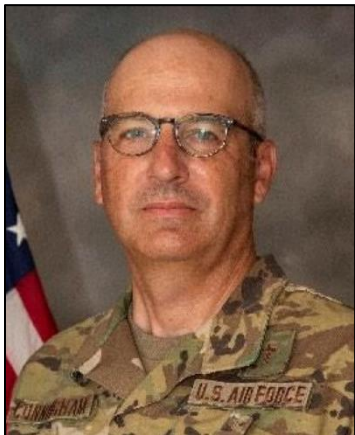

I am married to Janet M. Irvine, Vice President of Province V, Daughters of the King. Two stepsons and four grandchildren.

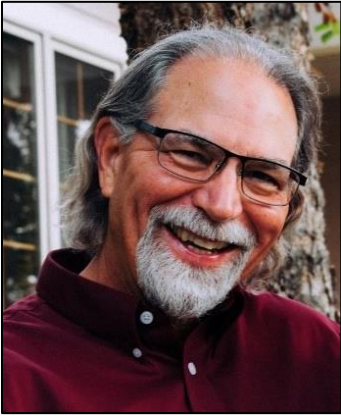

Michael Schmidt (St. Aidan's, Hartford)

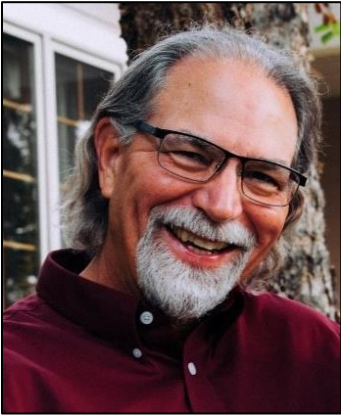
