# Diocese of Milwaukee Executive Council Minutes February 2, 2021 6:30 p.m. via ZOOM

#### Roll Call was taken.

At 6:30 p.m. The Rev. Joel Prather called the meeting to order and opened with prayer.

#### **January Minutes**

The Rev. Joel Prather asked if there were any additions, deletions or changes to the Executive Council minutes of January 13, 2021 Executive Council minutes.

\*\*\*The Rev. Scott Seefeldt moved and Ms. Janice Pauc seconded that the January 13, 2021 Executive Council minutes be approved as presented. The motion carried.

### **Monthly Finance Report**

Mr. Mike Weber, Diocesan Treasurer, presented the diocesan financial report for February, noting: "We are doing fine."

The Rev. Kevin Huddleston, Canon for Finance and Administration, reported that: --The new payroll process went well; more user friendly.

--Letters of Agreement/Memos of Understanding are being created for all entities the diocese is funding; essential paper trail.

Executive Council members requested a short "class" on the diocesan loan policy, previous loan decisions and current outstanding loans.

### DeKoven Center – Mr. John Vogel

Mr. Vogel gave a short history of the DeKoven Center task force progress to date and stated that they had a better sense of the purpose and direction of the committee.

The Rev. Kevin Huddleston noted that financial memorials for the Rev. Dr. Steve Peay will most likely be held by TFE for a "Rev. Dr. Steve Peay Archives at DeKoven Center."

#### **Standing Committee Report**

The Rev. Scott Leannah, President of the Standing Committee, reviewed the names/dates of the Assisting Bishops

He reported that:

--The Rt. Rev. Jeffrey Lee will begin serving April 1st, with a convention on June 26th, via Zoom, to officially elect him as Provisional Bishop.

--The annual diocesan convention will be October 9th; how and where it will be held is still under discussion.

--The Standing Committee, along with Mr. Mark Ehrmann, Chancellor, the Rev. Anne Hallisey, diocesan consultant, and the Assisting Bishop of the moment meet twice a month.

--Members of the Standing Committee are calling/meeting with parish leadership and the diocesan office:

- 1. to "take the pulse"
- 2. to be proactive, if financial assistance is needed

3. to address the underlying culture in the diocese, the way we communicate and operate, the many aspects of common life

The Rev. Joel Prather also called attention to the positive/proactive discussion at the Finance committee meeting with the Standing Committee liaison – handling financial assistance relationally.

## Haiti Project Report

The Rev. Steve Capitelli noted that:

- --The fourth quarter was good; they were able to fully fund the school until the end of the year.
- --Overall sustainability is murky.
- --Jenjenio Conserve, the "on-the-ground" liaison, has resigned.
- --There is restructuring on the steering committee.
- --Redevelopment after Bishop Jeffrey Lee is on board is a goal.

### 2021 Convention and Task Force

--Previous convention planning binder at least 10 years old.

--Ms. Barbara Klauber, Administrative Assistant, is preparing a list of convention roles and responsibilities

--Any names of "wedding planners" should be submitted to the Rev. Kevin Huddleston.

#### **Final Thoughts:**

The Rev. Joel Prather reflected that these are transitional months and that any "deep dives" will be held until the Right Reverend Jeffrey Lee is on board.

Mr. John Washbush wondered about filling the vacancy left by the resignation of the Rev. Kevin Huddleston; he said that the process is not noted in the Canon.

The Rev. Joel Prather will follow up with an e-mail asking for input.

Mr. John Vogel moved and the Rev. Steve Capitelli seconded that the meeting be adjourned. The Rev. Joel Prather led closing prayer.

The meeting was adjourned at 7:19 p.m. (a gift)
