At 9:30 a.m. The Rev. Joel Prather called the meeting to order and opened with prayer.

#### **September Minutes**

The Rev. Joel Prather asked if there were any additions, deletions or changes to the Executive Council minutes of September 20, 2020.

\*\*\*Mr. Ron Johnson moved and Mr. John Vogel seconded that the September 20, 2020 Executive Council minutes be approved as presented. The motion carried.

## Finance Report - Mr. Mike Weber, Diocesan Treasurer

Mr. Mike Weber reported that:

- --All parishes except one are current with assessments.
- --St. Matthias is at least three months behind; it is before the finance committee for review.
- --twelve parishes have requested the pro-offered month's waiver of assessment totaling about \$40,500.00.

\*\*\*Mr. Peter Larson moved and Mr. Ron Johnson seconded that the Executive Council receive the financial report as presented by Mr. Mike Weber. The motion carried.

### Standing Committee Report - The Rev. Scott Leannah, President

The Rev. Scott Leannah reported that:

- --a Q&A message was sent to the diocese.
- -- There will be two Assisting Bishops, each serving 1-2 months, due to timing.
- -- The Assisting Bishops will serve as resources and will not be salaried.

- --The Provisional Bishop will begin serving @ April 1<sup>st</sup>, with a convention, by Zoom, to elect him/her in June/July. The deputies to this convention are the deputies elected in 2021.
- --Liaisons from the Standing Committee will keep in touch with diocesan staff and other diocesan entities to build community.
- --"We have a lot of work to do."

### Task Force Updates

### DeKoven Center - Mr. John Vogel

Mr. Vogel reported that:

-- The Rev. Geoffrey Ward is now on the committee

Note: Mr. John Vogel clarified that the Rev. Geoffrey Ward serves as a resource person; he is not a member of the committee.

--He has a dual focus regarding DeKoven – its service to the diocese and its financial status Discussion brought in the need to clarify the by-laws and the relationship of DeKoven to the diocese -- ultimately who is responsible for DeKoven.

#### Constitution and Canons – Mr. John Washbush

Through discussion it was determined that, in this transitional time, the task force and review of the Constitution and Canons will be put on hold.

### Haiti Project Report - written

The Rev. Steve Capitelli noted that:

- -- The life of the Haiti project is perilous.
- --"Full discussion of the future sustainability and possible exit strategy will be held at the January, 2021 meeting.
- -- The Executive Council, led by the Rev. Steve Capitelli, prayed for the health and sustainability of Haiti.

#### Chancellor's Report

The Rev. Joel Prather congratulated Mr. Mark Ehrmann, Esq. the new chancellor of the diocese, and thanked Ms. Liz Orelup, Esq. for her continuing work with the diocese.

Mr. Mark Ehrmann reported that he is working with the Rev. Scott Leannah on the agreement for the Provisional Bishop.

The Rev. Kevin Huddleston spoke about the legal issue surrounding the Boy Scouts of America bankruptcy case and any relationship they have/may have had with any parish. The date for the reports from the parishes is November 16.

## Canon for Congregational Development Report - written

Canon Bean called attention to:

- -- the need to pay attention to the rural churches
- --up-coming planning meetings to address formation, the annual meeting and worship

#### Canon for Finance and Administration - written

The Rev. Kevin Huddleston called attention to:

- --webinars being offered
- --that the finance committee has received:
  - 1. Approximately \$80,000 in requests from parishes for financial assistance in 2021.

- 2. A request from St. Bart's Pewaukee for a 2<sup>nd</sup> month of Assessment forgiveness.
- 3. A signed offer on the Lazarus House in Janesville. Tentative closing date is November 16, 2020. Both the Bishop and Standing Committee have agreed to the sale of the property.

#### --brought the following motions --

\*\*\*The Rev. Kevin Huddleston hereby moved that The Reverend Kathy Monson-Lutes be authorized as the legal representative of the Episcopal Diocese of Milwaukee by the Executive Council for the purpose of conducting any and all business related to the sale of the Lazarus House in Janesville, Wisconsin. Mr. Ron Johnson seconded the motion. The motion carried.

\*\*\*The Rev. Kevin Huddleston moved the 2021 Housing Resolutions for the clergy employed by the Episcopal Diocese of Milwaukee be approved. (see below) Mr. John Vogel seconded the motion. The motion carried.

Huddleston during 2021, \$30,000 shall be designated as housing allowance (in lieu of the Episcopal Diocese of Milwaukee providing and maintaining a furnished residence for him), to be excludable from taxable income, within the meaning of section 107 of the Internal Revenue Code, to the extent that said housing allowance is spent by The Reverend Canon Dr. Kevin D. Huddleston for expenses of renting or providing a furnished home for himself and family, including rental or mortgage payments, insurance, utilities, furnishings, maintenance and repairs and other related expenses, up to the fair market rental value of said home, including furnishings and utilities. This housing allowance designation will apply to calendar year 2021 and all future years unless otherwise provided.

#### Housing Resolution for 2021 for The Rev. Donald Fleischman

RESOLVED, that of the total compensation to be paid to The Rev. Donald Fleischman during 2021, \$30,000 shall be designated as housing allowance (in lieu of St. Francis House providing and maintaining a furnished residence for him), to be excludable from taxable income, within the meaning of Section 107 of the Internal Revenue Code, to the extent that said housing allowance is spent by The Rev. Donald Fleischman for expenses of renting or providing a furnished home for himself and family, including rental or mortgage payments, insurance, utilities, furnishings, maintenance and repairs and other related expenses, up to the fair market rental value of said home, including furnishings and utilities. This housing allowance designation will apply to calendar year 2021 and all future years unless otherwise provided.

#### Housing Resolution for 2021 for The Rev. Kevin Stewart

RESOLVED, that of the total compensation to be paid to The Rev. Kevin Stewart during 2021, \$21,848.00 shall be designated as housing allowance (in lieu of the Episcopal Diocese of Milwaukee providing and maintaining a furnished residence for him), to be excludable from taxable income, within the meaning of Section 107 of the Internal Revenue Code, to the extent that said housing allowance is spent by The Rev. Kevin Stewart for expenses of renting or providing a furnished home for himself and family, including rental or mortgage payments, insurance, utilities, furnishings, maintenance and repairs and other related expenses, up to the fair market rental value of said home, including furnishings and utilities. This housing allowance designation will apply to calendar year 2021 and all future years unless otherwise provided.

#### Housing Resolution for 2021 for The Rev. Seth Raymond

RESOLVED, that of the total compensation to be paid to The Rev. Seth Raymond during 2021, \$24,000 shall be designated as housing allowance (in lieu of the Episcopal Diocese of Milwaukee providing and maintaining a furnished residence for him), to be excludable from taxable income, within the meaning of Section 107 of the Internal Revenue Code, to the extent that said housing allowance is spent by The Rev. Seth Raymond for expenses of renting or providing a furnished home for himself and family, including rental or mortgage payments, insurance, utilities, furnishings, maintenance and repairs and other related expenses, up to the fair market rental value of said home, including furnishings and utilities. This housing allowance designation will apply to calendar year 2021 and all future years unless otherwise provided.

--Finally, The Rev. Kevin Huddleston recommended setting, as soon as possible, the date for the 2021 convention and establishing a 2021 Diocesan Convention Task Force.

#### **Vice-President Updates**

The Rev. Joel Prather asked that the Executive Council read closely and carefully Canon 7 – Of the Diocesan Corporation and Executive Council. It will be part of the January orientation meeting along with how to read financial reports.

He also asked the members to consider new meeting dates and times (week nights? early a.m.?) He will send out a survey.
