#### The Rev. Don Fleischman (St. Luke's, Madison)

Don is the Rector of St Luke's Episcopal Church on Madison's East Side. The perspective to ministry that Don brings has been informed by being bi-vocational for most of his pastoral career. Because of this experience, he seeks to help folks integrate the sacred into every part of their lives.

Alongside Don's call to ministry, he had a 20-year career as a media producer at UW-Madison.
